### About the Role

This is a senior individual-contributor leadership role, responsible for advancing permits, maintaining regulatory compliance, and leading engagement with government regulators, Indigenous Nations, and local communities. The role is remote based, with regular travel to site, permitting offices, and community meetings.

The Director will act as a trusted internal advisor to senior leadership and work cross-functionally with environmental, engineering, operations, and external consultants.

### Key Responsibilities

1. Permitting & Regulatory Leadership
  - Lead and manage permitting strategies for mine development, construction, operations, and amendments in British Columbia.
  - Coordinate and oversee preparation, submission, and amendment of permits and regulatory approvals.
  - Act as primary point of contact with provincial and federal regulators and permitting agencies.
  - Track permit conditions, compliance obligations, and reporting requirements.
  - Anticipate permitting risks and proactively develop mitigation strategies.
  - Support due diligence and permitting inputs for project planning and development schedules.
2. Stakeholder & Indigenous Engagement
  - Lead engagement and consultation activities with Indigenous First Nations, local communities, and key stakeholders.
  - Support constructive, transparent, and respectful engagement aligned with regulatory and corporate commitments.
